

WHO: International Travel And Covid-19 Current Approach



- Vaccination proof not recommended as pre-requisite for border crossing: prioritising travellers denies vaccines to health workers
- Vaccine Equity Declaration: by 7th April 2021 health workers vaccination underway in all countries
- Risk mitigation measures for international travel to follow risk-assessment: regular, systematic, by-weekly
- Key focus: virus transmission opportunity -v- individual immunity
- Mixed-method: quantitative and qualitative including:
- a) Local epidemiology in departure and destination countries
- b) Travel volumes between countries
- c) Destination country's public health: health services capacity to detect, care for cases and their contacts, including travellers
- d) Departure and destination countries' public health and social measures to control spread of COVID-19
- e) Evidence on adherence, effectiveness of reduction transmission
- f) Contextual factors, including economic impact, human rights and feasibility of applying measures

WHO: International Travel And Covid-19 Current Recommendations



- All national authorities: up-to-date, proactive, transparent sharing of data on COVID-19 incidence, health services capacity and implemented public health and social measures. However:
- Departure countries detailed data not always available
- Destination countries experiencing community transmission: primary goal = not to overwhelm health system capacity
- Destination countries with no cases, imported, sporadic or few clusters: primary goal = maintaining their status
- Destination countries may resort to own travel-risk reduction and impose restrictions
- National authorities to publish their risk assessment methodology and list of departure countries to which restrictions apply
- Sub-national epidemiological information allows travel-related measures at the lowest possible administrative level

Domestic & CTA Travel - Expedient For This Year:



- Scale of vaccination and bi-lateral assessments by jurisdictions will determine approach/scale of Vaccine Passport requirements
- The UK Common Travel Area ("CTA") England/Scotland/Ireland- North & South/ Wales and Crown Dependencies will form the UK Jurisdiction for Vaccine Passport requirements
- Within the CTA evidence of vaccination will be determined by business sector assessment of duties to employees/customers (influenced by insurers?)
- Evidence will be electronic download of evidential certificate or some form of "Doctor's letter/certificate"
- Measures to suppress fraudulent evidence of certification

Domestic & CTA Travel - 2022 And Beyond:



- Highly dependent on success or otherwise of the pragmatic solutions of 2021
- Issue such as common standards/adherence to "international law and human rights" all the other costs and administration to be sat behind the scenes as "R&D" until the success of pragmatic solutions of 2021 are determined
